sole use of a specified individual.

If the trip is over-funded, the District Board  
reserves the right to direct such funds to  
another mission trip.

Refund Policy: Per IRS guidelines,  
contributions are not refundable. If a  
volunteer does not go on the mission trip,  
funds will first be used to pay for his/her  
administrative costs and any airline tickets  
already purchased. The District Board  
reserves the right to use any remaining funds  
for the referenced mission trip or any other  
District mission trip.
